There is a \$10.00 permit fee which will be donated to D.A.R.E. and the Free Public Library.

Application forms can be found online at www.hasbrouck-heightsnj.org. (left hand side under Action Center/ Forms/ Garage Sale Permits) Forms and payment can be dropped off at the Borough Clerk's office located at 320 Boulevard, between the hours of 9am-3:30pm. (checks preferred)

Application forms with payment (checks only) can also be mailed into the Borough Clerk's Office at the address noted above and the Garage Sale Permit will be mailed back to the resident.

Limited space is available for Hasbrouck Heights apartment renters and fundraising organizations at the Central Avenue Parking Lot. (Please note on the application form.) You will need to bring your own table.

Does not count toward the two garage sales permitted per year.

Deadline to register is Oct. 6, 2022 to get your name on the map. Free maps will be available on Friday in the Clerk's Office and Saturday at the main entrance of Borough Hall outside the Clerk's Office at 320 Boulevard. RULES AND REGULATIONS:

1. All Garage Sales shall be conducted between the hours of 9 a.m. and 4 p.m. only.
2. The person to whom such license is issued and the owner or tenant of the premises on which such sale or activity is conducted shall be jointly and severally responsible for the maintenance of good order and decorum on the premises during all hours of such sale or activity. No such person shall permit any loud or boisterous conduct on said premises, nor permit vehicles to impede the passage of traffic on any roads or streets in the area of such premises. All such persons shall obey the reasonable order of any member of the Police or Fire Department of the Borough of Hasbrouck Heights in order to maintain the public health, safety and welfare.
3. License must be prominently displayed on premises throughout entire period of sale.
4. The display or posting of signs on property other than licensed premises is strictly forbidden.
5. Sales and display must be confined to the garage, driveway, side yard, rear yard and inside your premises. No sales or display may be carried on in the front yard.
6. **No garage sale signs or advertisements may be posted on trees, telephone poles, street signs or sign posts within the Borough of Hasbrouck Heights.**
7. Any violation of the above Rules and Regulations is punishable, upon conviction by a fine up to Two Hundred Fifty Dollars (\$250.00).
